LICENSE REQUIREMENTS FOR PEDDLERS, SOLICITORS AND TRANSIENT MERCHANTS

The activities conducted under either a peddler, solicitor, or Transient Merchant License shall contain the following provisions as part of the permit:

1. No activity, whether soliciting or selling, shall occur prior to 8:00 a.m., nor continue after 9:00 p.m.

2. Permit validity:

- a. A peddler's license shall be valid for no more than three consecutive days, and no applicant shall receive more than two permits in any calendar year, being January 1 to December 31.
- b. A solicitor's license shall be valid for no more than 15 consecutive days, and no applicant shall receive more than two permits in any calendar year, being January 1 to December 31.
- 3. No licensee may use noise generating items to attract attention to his goods, wares or items for sale.
- 4. No licensee shall approach drivers of automobiles or in any way interfere with vehicular traffic.
- 5. No licensee shall have a fixed stand or location and shall not stop in any one place upon any street, alley or sidewalk any longer than necessary to make a sale to a customer willing to buy. Any licensee using a vehicle, whether motorized or not, when stopped shall place his vehicle parallel to and within 12 inches of the curb, and shall depart from such place as soon as he has completed sales with customers actually present.
- 6. No licensee shall peddle or solicit within the village parks, beaches or recreational areas.
