Wait list rules

- 1) The wait lists are managed according to the following rules. Each waiting list is managed at the Village Office. A copy of each list is available at the Harbor Office or the Village Office.
- 2) A non-refundable fee of \$100.00 is required to have a name(s) placed on each list. Positions are not transferable from one list to another. Any additional names will not be allowed on a seasonal slip contract when the applicant(s) is advanced to a slip. Ownership is determined at the time of the original wait list application.
- 3) We manage the following waiting lists:
 - a. Elk River I – Boats up to 24', no sail boats
 - b. Elk River II – Boats up to 30', no sail boats
 - c. Lake Michigan – Boats up to 30' – Min boat size 25'
 - d. Lake Michigan – Boats 31' to 38' – Min boat size 31'
 - e. Lake Michigan – Boats over 38' – Min boat size 39'
- 4) Overall Boat Length is determined by State of Michigan DNR guidelines as stated below:
 - a. Overall length of vessel includes bow and stern projections, which include but are not limited to:
 - i. Outboard motors
 - ii. Out drives
 - iii. Rudder
 - iv. Swim platform
 - v. Bow/stern railing
 - vi. Bow sprit
 - vii. Bow pulpit
 - viii. Lights
 - ix. Anchor and anchor mounting
 - x. Davits
 - xi. Dinghy
 - xii. Any equipment included in the overall length
- 5) If dockage is offered prior to April 1 in any calendar year and I refuse the offer, my position on the waiting list will be forfeited and my name removed from the list. Every effort will be made to contact the applicant; including sending a letter, emailing, and calling all listed phone numbers. If no response, the applicant will be removed from the list. There are no exceptions to this rule including but not limited to: applicant securing dockage elsewhere, doesn't own a vessel, and dockage which exceeds the length of vessel. To be placed back on the waiting list, a new application must be completed, and the application fee paid.
- 6) If dockage is offered April 1 or after in any calendar year, I have the right to refuse the dockage without penalty and my position on the waiting list will be retained.
- 7) If my address, telephone number(s) or boat information changes, it is my responsibility to provide updated information to the Village of Elk Rapids. I further realize that failure to do so, may result in my name being removed from the waiting list.
- 8) Acceptance by the Village of Elk Rapids of this application and fee constitutes placement on the waiting list only. It is in no way a guarantee that seasonal dockage will be offered to the applicant at any time in the future, nor does it constitute an agreement for seasonal dockage either expressed or implied.
- 9) The Village of Elk Rapids reserves the right to amend fees, policies and procedures relating to any part of the harbor and its waiting list. Applicant(s) is subject to any and all such changes enacted by the Village of Elk Rapids or the State of Michigan DNR.
