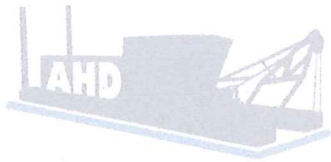

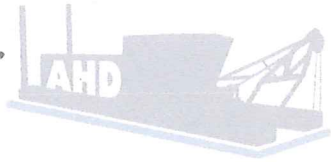

Scope of Work

- Remain in compliance with all state and local regulations and permits.
- Prep jobsite for hydraulic dredging.
- Mobilize all necessary dredge equipment.
- Begin dredging early to mid-April, 2024
- Remove approximately 5,000 cubic yards of silt/sand from the harbor entrance.
- Transport dredged material via pipeline to upland beach nourishment site.
- Complete oversight, coordination, and management of the entire dredge project.
- Maintain a professional and respectful work crew and project site.
- Inspection and approval of completed work.
- Complete dredging no later than May 15th, 2024.
- Withdraw all dredge equipment and leave the Edward C. Grace Memorial Harbor as clean and beautiful as when we arrived.



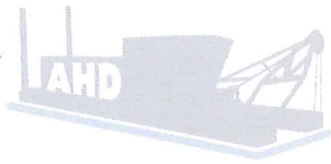


Our Dedication to Quality

Agreement to Services

AHD agrees to all terms of this contract for a total price of **\$85,500**. This contract requires 50% of the contract price to be paid upfront and before any work can begin. The remaining 50% being paid upon completion of dredging. Amounts shown in Table 1. This quote does not include construction of our own sediment retention pond. AHD will not be expected to provide any services to the beach nourishment site aside from moving the discharge pipe to control where the sediment accumulates inside the pit.
