

SECTION 1 - INVITATION TO PARTICIPATE

1.1 Purpose

Notice is hereby given that the Village of Elk Rapids ("the Village") soliciting a Request For Proposal (RFP) for the following: Fabricate a functional work barge that will be capable of setting navigational markers with a hydraulic crane, raising and lowering fixed docks, and placing swim zone buoys/no wake buoys in shallow waters that are considered boating restricted areas. The barge will need to be sufficiently powered with an outboard engine, have a spud system to hold its position while conducting work, and it will include all navigational safety features required by local, state and federal laws as required. The barge will need a trailer in order to be transported to the inland lake side of the harbor's large facility.

Respondents must offer a proposal that will meet the scope of services, requests and general description of work activities identified in this RFP, while adding what the Respondent would have to offer.

Presentation and Clarification of the Village's Intentions

As a result of this RFP, the Village intends to enter into a contract with the selected Respondent to supply the services described in this RFP. However, this intent does not commit the Village to award a contract to any Respondent, nor to pay any costs incurred in the preparation of the proposal, nor to procure or contract for any services. The Village reserves the right, in its sole discretion, to accept or reject, in part or in its entirety, any proposal received. At its discretion, the Village may award one or more contracts to one or more qualified Respondents to achieve the objectives of this RFP if it is in the best interest of the Village.

1.4 Timeline

The schedule of events for this RFP is anticipated to proceed as follows:

SECTION 2 - BACKGROUND AND SCOPE OF WORK

2.1 Background

The Village of Elk Rapids is a General Law Village and a rural community located in the southwest corner of Antrim County, Michigan. According to the 2020 census, the population of the Village of Elk Rapids at that time was 1,529.

The Village of Elk Rapids is a quaint community founded in 1855, with a traditional main street and a scenic river flowing alongside its central business corridor. The Village was established amidst agricultural fields, prominent water features and open land, much of which has retained its original character.

The Edward C. Grace Memorial Harbor was constructed in the 1950s by a group of dedicated volunteers. Completion of the initial harbor project was officially recognized by the then Michigan Governor George Romney during the Village's Harbor Days festival in 1961. Harbor operations have continually expanded over the years to the current capacity of 265 slips.

The Harbormaster is appointed by the Village Manager to supervise daily operations of all Village harbors and boating facilities. There are three full-time staff members who supervise approximately twenty seasonal support staff.

The Harbor Commission consists of seven members, serving staggered 4-year terms, who are appointed with the majority consent of the Village Council. One Village Council trustee is appointed to the Harbor Commission by the Village Council President. The Harbor Commission reviews all village projects that may affect the streams, lakes, rivers and shoreline within the village and all other waters as may be in the jurisdiction of the village, as they pertain to harbor facilities as established. The Harbor Commission will also make recommendations to the Village Council regarding harbor operations and harbor projects.

2.2 Proposal Information

It is the intent of the Harbormaster after receipt of bids to review available funding and proceed with the award process which includes the review and approval by a majority vote of support from the Edward C. Grace Harbor Commission and the Village Council of Elk Rapids.

2.3 Requirements

Expectations of Respondents:

- 1. Barge Length Overall (LOA) maximum of 26 feet
- 2. Barge beam not to exceed 10 feet
- 3. Outfitted with minimum of one (1) 125 hp gas outboard engine
- 4. Internal fuel tank to hold up to a 100-gallon capacity
- 5. Bottom plating approximately 1/4" minimum
- 6. Covered steering counsel, spud wells, deck fittings, pad eyes (lifting eyes), motor guard, tow post, navigation lights, bow flood light, manhole access, 12V electrical system, USB connection at helm, 120V inverter, vhf radio, hydraulic steering
- 7. Hydraulic knuckle crane for marine workboat use
- 8. 1 Trailer to transport barge
- **9.** Capacity full load minimum of 12,000 lbs. (including passengers/gear)






Figure 2: Harbor entrance.




Figure 3: Sunset over the Pavilion.
